

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.beexcellent.biz and Accelerated Administrative Services, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Accelerated Administrative Services, LLC include www.beexcellent.biz, AAS,LLC and Accelerated Business Consulting. The AAS,LLC website is a Business Consulting Services and Classes site. By using the AAS,LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, AAS,LLC may collect personally identifiable information, such as your:

Automatically Collected Information
